4. Details of our assessment

The non-compliance listed above was identified during our annual 2024 data audit. This audit assessed Dŵr Cymru Welsh Water's compliance at all their sewage treatment works and water treatment works with Operator Self-Monitoring (OSM) conditions, UV conditions (only applicable at some sewage treatment works) and Urban Waste Water conditions (delete as appropriate).

3.3.8 Late notification. Reschedule notification not notified in reasonable time (within 21 days). UWWTR notification for rescheduled sample was sent 33 days after original sample date.

It is to be ensured that any future notifications are made within a reasonable time. Please take this as formal advice and guidance.

Please note: this CAR is dated 31/12/24 as these non-compliances relate to annual 2024 data, however for clarity I carried out the compliance assessment on 14/5/25.
