4. Details of our assessment

NRW officer Ffion Jones attended site to inspect the hydropower scheme at Gilfach Farm on the 20th May 2025.

The weather was dry and the flow in the river was low. No water was being abstracted during this time. The HoF notch was clear with water running through. The required work from the previous inspections on the rock ramps to create pools for aiding fish passage has been completed. **It is recommended that maintenance work on the rock ramps is**

conducted following recent storm conditions.

No non-compliances were found during this inspection.
