**4. Details of our assessment**

The operator has submitted amended waste acceptance procedures for waste disposal activities within Cell 9 of Withyhedge Landfill (MP3330WP). The amended procedure only applies to wastes imported directly from Dauson Environmental Group Ltd Sites (Atlantic Recycling Ltd and Neal Soil Suppliers Ltd).

The document describes how the Operator will:

- Confirm that wastes accepted for disposal are compliant with the site's environmental permits.
- Obtain and assess the waste producer's basic characterisation.
- Confirm the waste's classification as inert or non-hazardous.
- Conduct on-site verification.
- Manage non-conforming wastes.

The revised waste acceptance procedures are presented in the operator's document titled:

- "RML - Waste Acceptance (NSSL ARL Only) - v1.4". Dated: 06 June 2025.

Following a review NRW have accepted the waste acceptance procedures set out in the above document, and the document will now form part of the permit; incorporated under Operating Techniques (Permit Condition 2.3.1 a).

The site's Waste acceptance procedures will need to be reviewed regularly to ensure they remain appropriate. Any proposed revision must be submitted to NRW for acceptance.

The following caveats apply to our decision:

- The accepted waste acceptance procedures are limited to the activities undertaken at the permitted installations at Withyhedge Landfill (MP3330WP & QP3098FL).
  - Acceptance of the procedures does not imply that any approval is given to the activities undertaken at other installations operated by the Dauson Group.
- The accepted waste acceptance procedures only apply to wastes imported from Dauson Group sites.
  - A separate/ revised waste acceptance procedure will be required ahead of waste acceptance from third parties.
- The accepted waste acceptance procedures only apply to wastes accepted for disposal within Cell 9.

- The procedures will require revision ahead of waste acceptance in other landfill cells.

The Operator should now ensure that staff understand their responsibilities under the revised procedures and the relevant training provided.

### Legal status of this report

Your permit is issued to you under the Environmental Permitting Regulations. You have a responsibility to comply with the conditions of your permit and prevent pollution/harm of the environment.
