## 4. Details of our assessment

Natural Resources Wales (NRW) officer Mark O’GORMAN and Jodie BASKERVILLE attended Torfaen HWRC Operated by FCC Recycling (UK) Limited, Panteg Way, New Inn, Pontypool NP4 0LS at 11.00am on Wednesday 28<sup>th</sup> May 2025 to conduct a unplanned routine site inspection of permit site EPR-LB3290HK. The weather conditions were clear and dry. Officers O’GORMAN and BASKERVILLE met with Technically Competent Manager (TCM) Mr Grahame Stennett who accompanied officers around the permitted boundary.

### PERMIT INSPECTION

At the time of the inspection the site was fully operational and open to the public. Site security was good, with CCTV in operation, anti-climb fencing surrounding the perimeter of the site, and there is presence of a security guard with a patrol dog during closed hours. During the inspection NRW officers were shown and explained the waste disposal procedure when members of the public attend site. All waste streams have separate storage containers. Staff at site regularly check if user’s waste is compliant with being disposed of in the correct way. NRW officers did not witness any offensive odours or excessive noises during the site inspection.

On 21/5/25 an online press article was released highlighting large quantities of wood overflow placed outside the designated wood containment area. FCC must ensure that all material is kept inline with permits conditions at all times. Upon the site inspection of 28/5/25 all wood storage was in line with permit conditions and presented no concerns, as shown in the below image.



Image 1 shows wood storage area in line with permit conditions.



Image 2 shows covered storage area for WEE products, kept clean and tidy in line with permit conditions.



Image 3 shows the storage area for food waste ( empty at time of inspection), which is emptied daily

to reduce the presence of pests on site.



Image 4 shows ongoing operations to maintain cleanliness on site and keeping material contained in permitted areas.
