A visual inspection of the outfall for Settled Storm Overflow at Rhuddlan Network Storage SPS outfalls was carried out on the 20th May 2025 by NRW officers.

Outfall A was clear, and free of fungus or debris.

Outfall B was also clear, and free of fungus or debris.

Neither outfall was discharging at the time of inspection.
