Withyhedge Landfill Phase 2 Surface Water Management system CQA

The permit condition 2.6.7 requires the operator to submit a Construction Quality Assessment (CQA) Validation Report, following construction of any landfill infrastructure.

In this case the CQA Validation report submitted will cover the engineering and construction of phase 2 surface water management system.

The following document was submitted by the operator, in order to discharge the CQA requirements for the construction of the landfills phase 2 surface water management system.

NRW officers requested some additional information regarding proposed timescale for additional work.

Dauson Environmental Group, Technical Manager supplied the requested information via email on the 2nd June 2025.

Following a review of these submissions, NRW can confirm that it accepts the CQA validation report for the engineering and construction of Withyhedge landfill phase 2 surface water management system.

Please note that the acceptance of this CQA Validation report for the above construction by NRW, does not mean that assumptions or designs specifications used for the construction of these lagoons will be suitable for future surface water management systems.
