4. Details of our assessment

Review of emissions monitoring Q1 2025 (January - March 2025)

Emissions monitoring data covering the period 1 January to 31 March 2025 was received on the 29th April 2025 in accordance with permit condition 4.2.3.

1. Emissions to Water

No exceedances have been identified within the monitoring return for emission point W1.

2. Emissions to Air

Continuous Monitoring (A5, A8, A9, A15, A17)

All continuous emissions monitoring was provided as required by the permit and shown to be within the permitted limits during this period. The site had its annual shutdown during January.

No schedule notifications were received for Q1 2025.

3. ARM and WDF Reporting

There were no updates to the alternative raw material / waste derived fuel usage for Q1 2025.

4. Noise

Seven noise complaints were received during the quarter. Four of these occurred during the annual shutdown in January, these refer to a drone that could not be linked back to site activities.

Quarterly noise monitoring was undertaken during March 2025. The monitoring indicated that recent works undertaken at the site to mitigate noise have been beneficial.

The Operator has proposed that noise monitoring be reduced to six monthly. NRW have agreed with this reduction in monitoring, however, if further issues on site are identified then a return to quarterly monitoring may be required.

Improvement Condition 10a states *"Following successful commissioning and establishment of routine steady operation of filter at emission point A11 the Operator shall undertake a noise impact assessment following BS4142:2014 and guidance set out in [Noise and vibration management: environmental permits - GOV.UK \(www.gov.uk\)](#). The assessment should include an objective assessment of narrow band (FFT) measurements to identify any tonal elements from on-site sources and off-site at sensitive receptors. The assessment should include consideration of the Welsh Government's Noise and soundscape action plan 2018-2023. Upon completion of the work, a written report shall be submitted to Natural Resources Wales for approval."*

A response to IC10a was received on the 6th November 2024. This has now been reviewed and no further action is required at this stage. The report indicates that the new BF41 filter fan does not significantly contribute to the offsite measured noise levels or acoustic character. The requirements of IC10a and 10b have been met.

5. Dust

Officers have agreed to a reduction in the frequency of dust monitoring from fortnightly to monthly. Results will continued to be reviewed and the frequency of monitoring may be varied again dependant on the results. The Operator should ensure that the Dust Management Plan is followed.
