4. Details of our assessment

I (Environment Officer Gavin Dodd) arrived at Cefn Mably Lakes, Cardiff on Tuesday 10th June

2025 at 11:00 to conduct an inspection regarding a licence to impound water. (Permit Number 21/57/12/0085). Site manager Owen Jones was present at reception and I explained what I would be looking at prior to commencing the inspection.

The inland water to be impounded under the permit was the Nant-y-Cor Fach. The grid references for impoundment specified in the permit were accurate.

The manner and extent of the impounding was for the creation of three fishing lakes which are marked on the permit, being excavated and constructed by earth dams. Lake one specified in the permit was itself split into three separate lakes for a total of five lakes on the site. However, the area covered by lake one on the permit includes the smaller two lakes above it within the boundary so the site is still compliant with this condition of the permit.

The overflow condition for the licence was also inspected and found to be compliant. The overflow from lake one was actively discharging into lake two. Lake two was not discharging into lake three, but the pipework allowing this to take place was clearly visible. The overflow from lake three was then set up to discharge into the existing culverted watercourse below the impoundment, though this culvert was dry on attendance.

The Nant-y-Cor Fach was checked downstream of the culvert and had a low flow.
