4. Details of our assessment

Routine site inspection

On 29th May 2025 my colleague and I carried out a routine permit compliance inspection at your premises.

At the time of the inspection, a discharge was not seen entering the watercourse. No evidence of sewage fungus, litter or odour were detected and no discolouration of the receiving watercourse seen.

We discussed the requirement for a sample point allowing a representative sample to be taken. You later submitted evidence (photographs) showing the outfall into the watercourse (having dye-traced) which is often under the water level, and the chamber of the man-hole situated directly below the treatment system. No other drainage/surface water enters this chamber/pipework so it was agreed that this would be the improved sample point. The man-hole will be labelled as such.

You also submitted a waste transfer note and confirmed the site is regularly emptied and maintained accordingly.

I am pleased to report compliance with permit conditions.
