Amending CAR form for Farmers STW following a request from DCWW to extend action deadline from 12/10/24 to 31/01/25.

This was a pre-planned audit carried out by Natural Resources Wales Environment Officers on 16/05/2024 who were accompanied by a DCWW Senior Operative and the DCWW South West Performance Manager.

The weather was dry at the time of the visit.

Officers were taken through the works from the inlet, through the treatment system, before finishing at the discharge point. The permit for the site is for the discharge of treated sewage effluent only; there is a separate permit for emergency discharge from the site (BN0077502).

The inlet flow is screened through copasacs and then flows into 2 primary settlement tanks. Secondary treatment is achieved by a percolating filter bed. At the time of the visit the arms on the filter bed were not turning. DCWW did mention that this site does sometimes suffer from dry weather flow. The recirculation pump is set on a timer however the recirculation pump had tripped and the electricity for the site had gone down whilst we were on site. An OPNOT was raised for this and a final OPNOT was received later that day stating that power had been restored.

The walls for the filter bed were being held together by a ratchet strap however this did not seem to hinder the treatment process and there were no obvious signs of leaks.

Following the filter bed treatment, the flow enters 2 final settlement tanks. There was a slight crack in the wall of one final settlement tank with evidence of some leakage.

Action: Survey final settlement tanks and carry out repairs.

The outlet is to the Afon Twrch. There was a slight discharge at the time of visit which was clear and there was no evidence of fungus surrounding the outlet.
