4. Details of our assessment

This CAR form relates to a pre bathing season inspection on the 9th of May 2025.

The site was fully operational and no storm discharge was occurring at the time.

The following observations were noted that required further action:

1. Screen Operation and Maintenance

The screens used to remove rag and large debris from the storm effluent prior to it entering the watercourse (if an overflow occurs) were partially obscured by rag. Although the screens were not in a condition that would be considered a non-compliance, We would advise that these screens need to be regularly cleared and checked to ensure that the effluent and debris do not overwhelm the screens and release un-screened effluent into the watercourse. The site needs to work as designed and in accordance with license condition 1.1.1(a):

The operator shall manage and operate the activity:

(a) in accordance with a written management system that identifies and minimises risks of pollution so far as is reasonably practicable, including those risks arising from operations, maintenance, accidents, incidents, non-conformances and those drawn to the attention of the operator as a result of complaints.

ACTION: We request that the brushes are checked and that they are working effectively. We would also ask that photographs are taken of the screens to confirm that the screens are operating as designed since our Bathing Water Inspection visit. **(Due by 30/06/25)**

2. Down-stream Channel Clearing

The main channel from the storm weir which conducts the effluent through the site, past the screens and Penstock had become partially obstructed by the accumulation of debris/sediment. This reduces the carrying capacity of the channel, making overflows more likely.

This is in breach of license condition 2.3.2(a):

The capacity of the sewer network downstream of the combined sewer overflow shall not be altered in any way which would lead to a significant increase in the frequency or volume of the discharge.

ACTION: This channel needs to be cleared immediately and regularly checked and cleared of debris on a more frequent basis. This issue has been observed previously and maintenance needs to be conducted more pro-actively. **(Due by 30/07/25)**

3. Logged Communication Failure(s)

The site log book indicated that there have been several communication failures with the site which would disrupt site telemetry being received by the control center. This system is vital for the appropriate management of the site and the appropriate response to any issue(s) which may occur. A failure in communication is in breach of license condition

1.1.1(a):

The operator shall manage and operate the activity:

(a) in accordance with a written management system that identifies and minimises risks of pollution so far as is reasonably practicable, including those risks arising from operations, maintenance, accidents, incidents, non-conformances and those drawn to the attention of the operator as a result of complaints.

ACTION: Can you provide clarification on the type of communication failure(s) that occurred, resolve and provide further detail in the site log book in future. **(Due by 30/09/25)**
