Routine site inspection. Peter Jones attended and met with site manager. Visual inspection of exterior of buildings for emissions such as dust from extractor fans, drainage and storage of materials including dead stock, there were no issues and no noncompliance identified.

The concrete yard was all in excellent condition.

No entry was made into the sheds to ensure Biosecurity procedures were maintained. Entry to viewing gallery in the one shed showed no issues.

Inspection then of all paperwork held in the office. All in order no non compliances identified.

Site is well maintained and clean. All staff training up to date and recorded.

No further action requested.
