Previous Report **CAR_NRW0046466** requested that:

"Therefore NRW would advise that DCWW carry out and provide evidence to prove that the spilled storm sewage does not reach the aquatic environment and that the asset is not currently used as a CSO. The methods for proving this were discussed and agreed upon with the Pollution Technician during the visit."

Extensions to the deadlines of the previous CAR were agreed and DCWW are still currently unaware if/where this asset discharges. this is a breach of compliance against Schedule 2.2

The discharge activities shall take place at the discharge point marked on the site plan at schedule 7 to this permit, and as listed in table S3.2;

Follow up actions are highlighted above for completion before **17/08/2025**.
