### 4. Details of our assessment

**Site Report**

On Monday 2nd June 2025 I carried out an inspection at Inland water (stream) known as Afon Ebwy Fach at Railway Inn, Abertillery. The permit is for a water resources impoundment licence for a fish pass/canoe pass, Permit Number WA/057/0012/009. I arrived on site at 13:20. The weather conditions were dry, warm and sunny. My Site inspection commenced at 13:25.

### **Observations**

I proceeded to check the Upstream extend of blockstone pre-barrage at National Grid Reference SO 21592 03833. I can confirm this was accurate (approximately) as stipulated by the permit. Please see fig 1 below.

I continued to check the Downstream extend of blockstone pre-barrage at National Grid Reference SO 21611 03808. I can confirm this was accurate (approximately) as stipulated by the permit. Please see fig 2 below.

### MANNER AND EXTENT OF IMPOUNDMENTS

To construct a rock ramp immediately downstream of the reinforced concrete channel consisting of four pre-barrages, each constructed with 1 metre by 1 metre blockstones, and each pre-barrage has a 0.5 metre wide by 0.25 metre deep low flow notch.

I confirm this to be accurate as stipulated by the permit. Please see fig 3 and 4 below.
