4. Details of our assessment

I attended site on an un-announced inspection, the weather was dry and cool following a relatively dry period. This CAR form also applies to Impoundment WA/055/0006/004

On arrival at the intake, it appeared to be well sited and in the style of the permit drawings. There was some build up of debris but the HoF notch was free-flowing and unobstructed. The scheme did not appear to be abstracting. I took some measurements of the structure, which did not match the design in the permit but my Hydrology colleagues have confirmed the site is compliant. I took photos and headed down to the outfall.

The outfall was facing upstream but into a pool so unlikely to cause scour. There was no discharge at the time of my visit, but I was unable to access the meter to confirm. There was an appropriate screen in place on the outfall.

Abstraction quantities were not assessed and will be reviewed on Abstraction Returns separately.
