4. Details of our assessment

On Monday 16th June 2025, Natural Resources Wales received an incident report (WIR 2505680) at 15:22 This incident referred to noise and dust arising from site. In particular, the complaint referred to noise from the crushing and screening operation at the top of the quarry.

On Tuesday 17th June 2025, Waste Regulation Officer Sarah Walton, attended the site boundary to investigate the report.

The NRW officer walked the site boundary on Craig Road between 11:50 and 12:20 to observe operations taking place on site and to listen for noise/vibration pollution.

There was a tracked excavator working on the top of the quarry in the North-Eastern side of the site. The excavator appeared to be putting soil into a screener. This activity was continuous whilst the officer was observing.

There was a continuous low whirring sound from the screener which was faintly audible from the site boundary. There was an occasional sound from the excavator moving. This tended to be white noise reversing sound (which is a listed mitigation in the site's Noise Management Plan).

No breaches of the site's Noise Management Plan were observed, therefore the officer did not enter the facility.
