4. Details of our assessment

Routine inspection of Asset. The weather conditions were dry and sunny at the time of the inspection.

The site is a Wastewater Treatment Works that processes sewage effluent. The permit (BH0050701) for the site is for the discharge of secondary treated sewage effluent. Final effluent from the site is discharged to the Afon Tywi

Officers were taken through the works from inlet, through the treatment system, and the final effluent sampling station. Officers checked the discharge point to the Afon Tywi, there did not appear to be any evidence of an impact to the receiving watercourse.

Records checked (random selection) on site from log book. No ongoing issues identified.

The Process

Effluent enters the site at the inlet and flows through primary settlement tank, followed by secondary treatment via two filter beds. The arms on the filter bed were moving freely and there did not appear to be any issues with pooling and excessive vegetation on the media in the beds. There was an operative on site removing vegetation from the filter beds at the time of the inspection.

There is a macerator on the inlet, with any rag that accumulates at the inlet being manually removed and taken away to skips on another site.

There is a storm overflow on the inlet, with storm discharges flowing to a storm tank where it settles before it discharges to the environment when the storm tank is full. There is a probe in the storm tank that is used for EDM.

The storm overflow at this asset has been identified as an unpermitted discharge, this is being discussed separately.



Permit breach

Condition 2.2.1 The discharge activity shall take place at the discharge point marked on the site plan at schedule 7 to this permit, and as listed in table S3.2.

There was sewage leaking out of cracks in the brickwork of the storm and sludge tank with evidence of some effluent pooling at the base tanks. Officers discussed the need for these cracks to be repaired to prevent further discharge to ground in this location.
