4. Details of our assessment

This compliance form is the result of a compliance inspection of the DCWW asset - Ynys Bridge CSO, carried out by NRW on the 18th of June 2025.

Arrived at site with officer Harry Warburton and met with DCWW at 11:40am. Weather was

dry and sunny at the time of the visit.

Made our way to the inspection chambers of the CSO which looked to be in decent condition, although this asset does not have screens.



Went down to check the outfall which was difficult due to the path towards it was very overgrown which indicates that it hasn't been maintained in a while. This was confirmed by the condition of the outfall where the bar screen showed visible evidence of debris which needs to be cleaned.



NRW recommend that DCWW look to carry out more regular maintenance on the bar screen at the outfall and request the most recent maintenance activities for this be provided.

Looking at the DCWW storm overflow map, this asset last went into the "spill" state on 05/06/2025 at 12:00pm for 30 minutes. As a result of this, NRW have requested spill data for this asset as this asset used to have historic problems with non-compliant spills.
