The operator holds a Standard Rules SR2008 No11 Permit.

Weather on day of inspection, was clear, dry with little wind.

Report Findings

On arrival at the permitted site, it was apparent that there has been no activity on the permitted site recently and that the site is currently non-operational. However, the operator still wishes to keep the permit they hold live and active.

Due to the site being non-operational there are no permit conditions to assess against and therefore no permit actions or breaches to be recorded.
