### 4. Details of our assessment

A routine effluent sample collected from Bro Nant Sewage Treatment Works (STW) on the 27/03/25 was found to contain 31.5mg/l Suspended Solids.

As per permit condition Discharge d) (ii), the discharge shall contain no more than 30mg/l Suspended Solids. This result is a permit breach and is scored accordingly.
