4. Details of our assessment

Alastair Krzyzosiak attended the site to undertake an inspection on the 6th June 2025. It was not possible to locate a copy of the permit. Originally issued in 1999 and transferred in 2011, NRW does not appear to hold a copy of the permit. Nor do the permit holders have a copy in the branch. It is likely that the permit has been lost as previous iterations of both organisations have changed over the years.

It was not possible to inspect the discharge as the location is heavily overgrown and inaccessible down a steep/muddy bank.

Discharge is described as a trade discharge, site drainage. Permit limits are as follows:

- Suspended solids - 100 mg/l
- Oil: Total mineral - 10 mg/l
- Flow, instantaneous - 53 L/s
- Matter, poisonous or injurious to fish - 0 (Zero)
