Briefly describe what you want to do

Ocean Ecology Limited are seeking to proactively survey key strategic offshore development areas with a view to developing a robust environmental baseline dataset which offshore wind developers will have to hand almost immediately following leasing a development area. With this we are looking to significantly accelerate the development of offshore wind in the Celtic Sea, working to support Net Zero targets but also accelerating direct industry benefits particularly in South Wales (e.g. ports, transmission partners, engineering, etc.).

This offshore survey will entail the collection of seabed imagery (via a drop-down camera system), collection of sediment grab samples, and collection of water samples for eDNA analysis. Up to 44 grab samples will be collected with an average retention of 10-15L per sample, equating to a removal of up to 0.66m³ of sediment.

All proposed sampling stations will be cross-checked against all available data for infrastructure (cables, pipelines, etc), wrecks and navigational restrictions, as well as in consideration of the relevant admiralty charts. These locations have additionally been approved and cleared of any concern by the Maritime and Coastguard Agency, Trinity House, and the Royal Commission on the Ancient and Historical Monuments of Wales.

Prior to the collection of any grab samples, the seabed will be visually screened using a drop-down camera to ensure the absence of any sensitive environmental or cultural (archaeological) features, infrastructure, or potential UXOs.

Please note, this is a distinct separate application to that made under payment reference PRCAPPOECOL121. Applications have been divided due to commercial reasons with data collected relevant to different future clients and therefore requiring different licences.

Ocean Ecology are seeking to complete this work pro-actively and therefore without any current client providing financial backing. We are therefore at significant risk of this work being devalued and potentially undermined to the point that we would not be able to carry out the survey. Given the aims of this work, to significantly accelerate the development of offshore wind in the Celtic Sea, working to support Net Zero targets but also accelerating direct industry benefits particularly in South Wales (e.g. ports, transmission partners, engineering, etc.), we feel it a valid approach to, at this stage, render the works and application confidential. Additionally, this survey approach and initiative is the sole intellectual property of Ocean Ecology Limited and is within our rights to protect at this stage. Data and survey findings will, by the nature of the targeted approach, become public at the appropriate time through the standard development consenting processes.
