4. Details of our assessment

This was a routine unannounced site inspection carried out by Natural Resources Wales waste regulation officer.

The weather was very dry and sunny.

The site was operational with site operatives sorting waste in the yard.

The site owner, Andrew Brown, was present throughout the inspection.

W2E- Waste acceptance

A few customers arrived at the time of inspection and the waste acceptance procedure was witnessed.

On the main yard, the area to the left was being used to sort incoming waste by the site operators.

The inert waste pile was substantial but appeared to be within the permit limits.

It was noted that the interceptor was not accessible and was covered by inert waste.

This has been raised during previous site inspections.

Action: Access to the interceptor should be maintained at all times for general maintenance/in case of emergency. For immediate compliance.

W2D Site security

The site fence has been fixed as requested during the previous inspection. The site also benefits from a number of security cameras.

W3A (2) Emissions to air - Dust

It was noted that the activities on site caused some dust to circulate in the air.

As the weather had been very dry over a number of days, please ensure that this issue is mitigated as soon as it arises. For ongoing compliance.

(W1A) General management

Working Plan/Environmental management System -EMS

It is noted that the Working Plan has not been updated since 2005. This has been discussed with the owner.

Action: Please revise, update and submit your Working Plan/EMS for assessment. Please comply by the **21st of November 2025**.
