4. Details of our assessment

On the 16/5/2025 NRW were alerted to a spill from Llangernyw STW to the watercourse. This was initially reported as an early warning and upgraded to a self report. A storyboard was submitted stating the cause of the spill was due to a miscommunication resulting in the

humus return valve being left open whilst the recirculation pump was fixed and not closed when the pump came back on line. This resulted in a spill from the filterbed distribution chamber from the overflow pipe.

The spill is a breach of condition 2.3.2 which refers to S3.2 stating that secondary treated effluent should only be discharged from the designated point as specified in the permit. This breach has been scored as a **CCS 3** and a **warning** has been issued as an enforcement response.
