4. Details of our assessment

A routine effluent sample collected from Waters Edge Leisure Park on 12 June 2025 was found to contain 22.7mg/l ammoniacal nitrogen. As per permit condition 1.6 on your permit,

the discharge shall contain no more than 10 mg/l. As the volume of flow being discharged is small in relation to the receiving waterbody (Teifi Estuary), we believe that there would be significant dilution therefore, the above breach has been recorded as a category 3 non-compliance.

In response to the above, please investigate and explain why this exceedance has taken place and what action is being taken to prevent any further exceedances by the **22 July 2025**.
