4. Details of our assessment

Llanddulas Compost Site, Site Meeting and Inspection - 24th June 2025.

Accompanied by Mr. Leon terrace and Mr. David Bailey of FCC Ltd., a routine inspection was undertaken of the compost site, including compost windrows, shredding area and water collection lagoon.

The perimeter odour control system and site odour levels were also visually checked.

All operational parameters were within permit limits and the site is being run and maintained to a good standard with no outstanding compliance issues. None of the windrows appeared anaerobic and the windrows were low in odour profile.

No off-site odour was detected at the time of inspection and no complaints have been reported to NRW this year which is an excellent compliance outcome.
