4. Details of our assessment

I attended the site on an un-announced inspection, the weather was dry, bright and warm though there had been some stormy-showers in the previous few days. River levels were generally low. This CAR form also relates to Impoundment 19-55-15-0503.

I arrived at the intake where it became apparent that the scheme was in a residential garden – apologies for any intrusion. Due to the size and location of the scheme, it was not possible to get accurate measurements to compare against the drawings but the scheme appeared to be built as designed. It was not abstracting at the time of visit and HOF was flowing freely.

I headed down to the outfall but was unable to confirm it's exact location due to vegetation growth and the geography of the site. The scheme appears to be compliant.

Abstraction records were not assessed during this inspection and will be addressed separately.
