4. Details of our assessment

This was a routine, unannounced site inspection visit by Waste Regulation Officer Joe Weatherley, of Natural Resources Wales. Upon arrival at 14:50 hours the officer was greeted by the site manager for the day. The officer signed the attendance sheet in the site office and commenced the site inspection accompanied by the site manager.

Both incoming and outgoing streams consist mainly of waste mattresses and the separate fractions resulting from their treatment. The treatment consists of removal and separation of the fillings and covers from the mattress springs. This is carried out using machinery situated in one of the buildings on site. As the operation had ceased for the day, the machines were turned off and the officer didn't see the process at work. The work area was kept very tidy and operatives were busy sweeping the floor of this area during the inspection visit.

Advice and Guidance : The site accepts and stores waste fridges and freezers. As this is not a permitted activity an exemption is required. The site had the relevant exemption in place but it had expired 4 days before the visit. This exemption has since been re registered Please ensure all on site waste activities are covered by the site permit or the relevant exemption, at all times.

A separate email has been sent advising of the approaching changes to waste exemptions and the implications for permitted sites.
