4. Details of our assessment

This was an unannounced site visit to the site to check for compliance with the actions set out in the previous CAR report dated 03/12/2024. Upon arrival at the site the officer was greeted by the site manager who invited the officer to sign in the visitors log and read all site relevant safety instructions. A site operative then accompanied the officer during the visit. The majority of the planings had been removed from the non permitted area and are now stored within the permitted area. Some planings remain as a bund along one side in the non permitted area. The site manager explained that this material is tarmac planings mixed with other materials and therefore cannot be processed and recovered. Arrangements have been made for this material to be removed.

Action : Please ensure any waste materials associated with the permitted operation, remaining in the non permitted area (outlined in red in the diagram), are removed by 31/07/2025. Please provide Natural Resources Wales with waste transfer notes after the materials have been removed.
