4. Details of our assessment

This Compliance assessment report (CAR) has been raised after Senior Industry Regulation Officer Carter Shone visited the Wynnstay site. This was a pre-arranged site inspection.

Permitted activities

The officer was given a full tour of the site.

No non-compliances were observed.

Odour and Noise Emissions

No odour or noise pollution was detected arising from the installation during the inspection.

Emissions of substances not controlled by emission limits

The site's new oil interceptor in the south west corner of the installation was inspected. This was part of the site's drainage improvement works made in response to actions as detailed in Compliance Assessment Report reference CAR_NRW0044946.

The new interceptor, which has an automatic shutoff valve and sensor, now controls outflow of all site drainage, it also controls any outflow from the existing oil interceptor.

The new interceptor satisfies the Action from CAR_NRW0044946 to bring the site back into compliance.

Action 1: Send a copy of the new site drainage plan and procedures for the new interceptor when completed.

Permit variation

The operator is installing a new CHP engine and is hoping to have it installed by the autumn 2025.

This new CHP will require a permit variation before it can be legally operated. The Operator is reminded to submit a permit variation application at the earliest opportunity due to NRW's current 8 - 12 month permitting queue resulting in delays to the determination process.
