4. Details of our assessment

An OSM sample was taken on 23rd May 2025, resulting in the following exceedance:

Biological Oxygen Demand result 61 mg/l. The permit limit is 45 mg/l - this is the second exceedance for BOD at this site within the last 12 months.

The above result is not classed as a failure as it is within the allowable number of exceedances based on the LuT (Look-up Table) and sites sampling frequency.

DCWW believes that this was caused by insufficient cleaning of the humus tanks when they were emptied on routine maintenance due to insufficient pipework on the tanker

carrying out the task causing a short-lived deterioration when they re-filled. DCWW have reviewed the task and have allocated a specific team to undertake this job going forwards ensuring they have all appropriate kit available at all times.
