4. Details of our assessment

The site was visited as a joint visit between Dwr Cymru, NRW, a local resident and the local harbour master. This was following continuing discussions about the varying levels of discolouration of the sea where the Afon Goch Amlwch discharges to the sea from the old Octel chemical works site.

The final effluent at the sewage works and the river discharge were inspected.

It was seen that the effluent draining from the sewage works was clear as compared to the reddish metal rich discharge from the Afon Goch Amlwch which drains from the old Parys Mountain copper mines.

Two photos are attached showing the final settlement tank at the sewage works and the Afon Goch discharge to the sea.
