4. Details of our assessment

This report details the site visit made on the 25 June 2025 to Recresco Limited, permit reference number EPR-DB3797TC. Natural Resources Wales (NRW) Officers Carla CURTIS and Mark O'GORMAN attended site at 11:00 to conduct an unannounced routine inspection, the Depot Manager accompanied officers around the site.

The site has recently installed a new gas dryer to replace the older diesel dryer being used as part of their operations. At the time of the inspection the new gas dryer was being serviced, the Depot Manager advised that it has been running well. No odour reports have been received by NRW since the installation of the new gas dryer on 11 March 25.

Action – Please can you update and submit your Environment Management System to reflect the changes made to operations on site with the installation of the gas dryer – **Deadline 31 July 2025**

The following observations were made during the site visit. The site was operational at the time of inspection, the glass product stored outside is due to be shipped to Portugal the next week or so, this will go from Newport docks.

WASTE ACTIVITIES All the waste and product storage bays were all clearly labelled. The dust suppression system was working well on site.

DRAINAGE SYSTEM The drainage is working efficiently and is regularly maintained.

SITE INFRASTRUCTURE The flooring on site was in good condition. General housekeeping on site was maintained to a good standard and no causes for concern were identified. There was no excessive noise along with no offensive odours witnessed by NRW Officers especially near the dryer section of the site.

WASTE RETURN SUBMISSIONS - These are up to date and correct, the total quantity of waste accepted at this site must not exceed 220,000 tonnes per annum. Based on the submitted waste return data for the last four quarters of 2024/2025, the total waste accepted was 173,935.32 tonnes which is within the site's annual threshold.

TECHNICAL COMPETENCY The site TCM is John Maddox. The certificate expires 25 November 2026.

PERMIT COMPLIANCE AND BREACHES - No permit non-compliances were identified on this visit and thus no breaches have been scored.
