4. Details of our assessment

This report details the site visit made on the 10th June 2025 to at the Bryn Pica Landfill Site, permit reference number EPR/DP3732SQ.

Natural Resources Wales (NRW) Senior Officer Greg GARDNER and Lead Specialist Mostyn WALL attended the Bryn Pica Landfill Site, Llwydcoed, Aberdare, Rhondda Cynon Taf CF44 0BX for a planned routine site inspection at 13:30pm where they were met with Site Manager, Mr Lee FOULKES. The weather was dry, sunny and reasonably mild at the time of the inspection.

FIRE INCIDENT - 23/05/25 - WIRS 2504977

On 23/05/25 at approx. 09:10am, NRW received notification from the site (Ref: WIRS 2504977) that a fire had occurred on a truck unloading waste at site (Photo 1). The SWFRS (South Wales Fire and Rescue Service) attended site and extinguished the fire at approx. 11:45am. NRW Lead Specialist Mostyn WALL attended site to manage any potential environmental issues such a firewater runoff. The fire water was contained within the landfill waste mass and will be treated as part of the leachate treatment system.

The fire damaged waste was moved to a quarantine area on site and managed where no further re-ignition occurred. The cause of the fire was a suspected battery located within the waste(s) which ignited. The site have introduced further checks with the waste supplier to prevent any future reoccurrence.

Action: Report back to NRW any changes made to the sites EMS or operations following the sites fire investigation and from feedback from the FRS.

GENERAL OBSERVATIONS - 11/06/25

The purpose of the visit was to conduct a site handover from Officer WALL to Officer GARDNER and to become familiar with the sites operations, process and surroundings. Discussions took place regarding current site operations and future intentions such as any planned maintenance. Mr. FOULKES walked NRW Officers through the process where it was noted that there were no offensive odours witnessed both inside and outside the permitted boundary and / or excessive noise / dust witnessed (Photos 2-5).

The gas wells appeared to be maintained and the ones inspected in good working order. NRW Officers ventured to the leachate lagoons which were in good working order and not at capacity. There was evidence of pest control measures taking place on site which assisted in the management of waste operations.
