4. Details of our assessment

Bio-aerosol monitoring

Bio-aerosol monitoring was undertaken in accordance with Condition 3.7.1 (a). The permit requires bioaerosol monitoring to be undertaken twice a year.

Table S3.1 specifies limits for bio-aerosol concentrations as:

- Total bacteria - 1000 cfu/m³
- *Aspergillus fumigatus* - 500 cfu/m³
- Gram negative - 300 cfu/m³

The bio-aerosol monitoring was undertaken on 29th April 2025 and the concentrations were compliant at all sampling locations during this monitoring exercise.
