4. Details of our assessment

Monitoring Returns

Air emissions monitoring for the A1 stack from the air treatment system is required to be undertaken once every 6 months. Monitoring was undertaken on 30th April 2025 in accordance with Permit Condition 3.5.1 (a).

The results for odour, dust and TVOC were compliant with the emission limits specified in Table S3.1. The odour abatement efficiency was 94.8%.

Bio-aerosol monitoring was undertaken on 29th April 2025 in accordance with Permit Condition 3.5.1 (c). The permit requires bioaerosol monitoring to be undertaken twice a year.

Table S3.4 specifies limits for bio-aerosol concentrations as:

- Total bacteria - 1000 cfu/m³
- *Aspergillus fumigatus* - 500 cfu/m³

The results were compliant with the limits at all sampling locations.
