4. Details of our assessment

NRW officer Ffion Jones attended Abercynafon Farm to inspect the hydropower scheme on the 10th June 2025. Please see below actions and guidance following this inspection.

The intake was observed from a distance as it was too dangerous to assess thoroughly and therefore, some parts of the permit could not be reviewed.

1) Please install a mesh screen on the end of the discharge pipe to prevent the entrapment, entrainment, or impingement of fish as per condition 9.5 of your environmental permit (WA/056/0041/001)

9.5 Before any abstraction takes place the licence holder shall install to the satisfaction of the Agency a 12mm screen to prevent the entrapment, entrainment or impingement of fish at National Grid Reference SO0805017571 at point 'Q' on the Licence Map.

The Licence Holder shall maintain the fish screen in accordance with the manufacturers specifications and keep records of such maintenance available for inspection.
