4. Details of our assessment

Natural Resources Wales officer Ffion Jones attended the hydropower scheme at Pwll yr Hwyaid Farm for inspection on the 10th June 2025. Please see below actions and guidance following this inspection.

1) Please ensure the Hands off Flow is cleared of any blockages and complies with

the permit conditions by the 28th July 2025. Once the blockage has been removed, please ensure that this is maintained, particularly until the river bed has re-stabilised. Materials upstream of the HoF notch loosened and removed for up to a metre so that there is space upstream to encourage flow.

9.5 (i) No abstraction of water shall take place unless the rate of flow in the Cwm Cwy immediately downstream of the authorised point of abstraction, marked as 'Point A' as specified in condition 2.1, is equal to or greater than 11 litres per second and the abstraction shall not cause the flow immediately downstream of the said abstraction point to fall below that rate.

(ii) The quantity of water abstracted shall not exceed 80% of the available flow in the Cwm Cwy in excess of 11 litres per second.

9.8 The Licence Holder shall ensure that during construction works and any subsequent maintenance work to the hydropower scheme, that the flow in Cwm Cwy is allowed to pass downstream unchanged in quantity and quality at all times.

The photograph below demonstrates that the Hands off Flow is blocked which results in the flow requirements/limitations of the permit not being met.
