This Compliance Assessment Report (CAR) has been raised in relation to the Q2 2025 monitoring returns.

The Q2 monitoring returns were received on 14th July 2025 for discharges from W1 and W2 emission points in compliance with permit condition 4.2.3. The monitoring was undertaken in accordance with permit condition 3.3.

All reported parameters were in compliance with the emission limit values (ELV's) stipulated in Schedule 3 (b) Table S3.2.
