4. Details of our assessment

Compliance inspection of discharge permit AN0086101 for CSO at Bridge Road, St Mellons. Inspection undertaken by Environment Officers Harry Warburton and Alex Grainger, accompanied by DCWW pollution technicians. Weather at the time was dry and hot.

The inspection chamber was lifted and the overflow pipe for the CSO discharge is within, above the flow channel. The EDM monitor is also located here. The discharge occurs by the flow in the channel reaching a certain height before entering the overflow pipe, which flows into the surface water line and discharges to the Rhymney. The outfall was inspected and there was no signs of impact. There was some litter present outside the outfall,

however this is not discharge related.
