4. Details of our assessment

On 30 June 2025, Natural Resources Wales received a Stage 2 Trigger Exceedance Close-Out Report for Penmaenmawr Promenade Pumping Station (CG014830). NRW acknowledges and accepts the recommended action to reconfigure the pump operation from a duty/standby configuration to a duty/assist configuration.

However, we would like to highlight that a Stage 2 Close-Out Report is appropriate only when all investigative and corrective actions are completed within three months of the original Compliance Assessment Report. In this case, the original CAR, associated with the Trigger Breach Notification,

was issued on 18th September 2023. As this timeframe has been exceeded, the appropriate close-out stage should have been recorded as Stage 6.

We kindly request that Dŵr Cymru Welsh Water ensures adherence to the TBN process in future submissions, particularly regarding the correct classification of close-out stages based on the timelines of investigation and remediation.
