### 4. Details of our assessment

CARS form generated following site inspection of the Pen y Bont water treatment works (CG0174901) on the 03/07/25.

The Natural Resources Wales environmental officer for Meirionnydd and Dwyfor met with the environmental risk specialist, the performance manager and the process scientist from Dwr Cymru.

During the visit the inlet to the works was inspected, the DAF which is the first step in treatment where suspended solids are removed from the water. Following this the tanks that filter the water through the sand were inspected. We then looked at where the pH correction

and chlorine is added to the water. We inspected the lagoon which is used to store water from the site and any cleaning down of tanks and inspected were this discharges to the watercourse after settlement. The sample point prior to any run to waste discharges was also inspected. There was no access to view where this discharges to the watercourse.

No issues of non compliance at the site identified. Thanks for your cooperation and the site visit.
