4. Details of our assessment

Waste returns

Shield submitted their Q1 2025 waste returns to NRW on 29th April 2025.

Waste codes 170601 and 170605 were reported, these codes are included in the list of waste codes in Table S2.2 of the permit.

Actions carried forward

CAR_NRW0046381 included the following two actions.

Action 1. Please undertake a root cause investigation into why the correct annual reporting forms were not used.

Response received. “There has been a change in Senior Management since this requirement came into effect and unfortunately this was not handed over or implemented. We now have a system in place to ensure that this will be sent over annually as required as part of our permit.”

Action 2. Please undertake a root cause investigation as to why permit condition 2.4.1 has been breached.

Response received. “We have looked into this and this was an oversight on our part. We have separate skips in our yard which have now been labelled to identify and ensure that they are segregated.”

A C4 non compliance with permit condition 4.2.2c was issued for failure to submit the specified forms. A C3 non compliance with condition 2.4.1 was issued for fixing of hazardous waste on site.

Further to receiving the above responses, an EMS audit was scheduled for 30th April 2025 to ensure that the management system includes a suitable management of change procedure and that the permit is accessible any person having duties that may be affected by the mat.

The above actions are now closed.

EMS Audit

An EMS audit was scheduled for 30th April to ensure that permit condition 1.1.1 is complied with. The audit report is being finalised and will follow in a separate CAR.
