4. Details of our assessment

IQE Silicon site visit CAR

This CAR is to record a site visit by Natural Resources Wales (NRW) Officer B Armstead to IQE Silicon (Cardiff) on 7th July 2025 and to record receipt of monitoring reports required by under permit condition 4.1.2.

IQE Silicon are in the process of vacating their St Mellons site and have advised NRW of the following progress being complete as of 2nd July 2025.

- There is now a skeleton crew at the IQE Silicon site with no onsite operations.
- All 5 reactors and associated pipework have been removed from the building so there are no emissions to air from the reactors.
- The hydrogen system has been decommissioned and removed from site.
- Large amounts of hazardous waste has been removed via a licensed hazardous waste carrier.
- An operational clean room and wafer cleaning wet deck remains on site, however IQE have not used the wet deck yet as operational improvements are underway.
- All gases have been removed from the site.

A site visit was undertaken which confirmed the removal of reactors, abatement equipment and hydrogen system. A site walk over confirmed that the site remains in an orderly condition with no excessive waste accumulations.

The wet room with wafer cleaning station remains on site along with the associated water treatment facility, wastewater treatment plant, N2 tank and plant.

The wafer cleaning chemicals remain on site contained in 200l drums, These were viewed during the site visit, and remain stored in bunded cabinets.

Sewer Emissions

Form S1 was received for January to June 2025 on 4th July 2025.

Suspended Solids (mg/l) - Results were within permitted limits

pH - Results were within permitted limits.

Air Emissions

Form A1 and A2 received for January to June 2025 on 4th July 2025.

Blank form submitted

There was no air emissions monitoring undertaken at the Silicon facility in the first half of 2025 as

decommissioning of the site has meant that reactors were not running.
