4. Details of our assessment

Introduction

This Compliance Assessment Report (CAR) is regarding a Site Visit undertaken on the 3rd of July 2025 by Natural Resources Wales (NRW) to the Pwllfawatkin Landfill Complex, which is managed by FCC Environment (the Operator) under permit number EPR/BU8819IV.

Scope

This was a pre-arranged visit, the purpose of which was to attend the fourth periodic progress meeting. These meetings (which are organised by the Operator) are held on a fortnightly basis and provide an opportunity to gain insight into the progress with the Permanent Capping and Restoration Soils Works 2025. Furthermore these meeting also facilitate any operational or logistical issues or concerns to be raised and addressed.

Representatives from the following companies/organisations were in attendance:

- Sirius Group
- Jones Bros Civil Engineering
- INFINIS Energy
- Carmarthenshire County Council (CCC)
- Natural Resources Wales (NRW)

Site Observations

The NRW Officer arrived onsite at 09:45 and were met by the representatives of the companies involved with the proposed capping works. The key discussion points of the visit are summarised below:

- Tip 890 is predominantly covered with restoration soils, with only a small section of exposed GDL (*Image 2*) awaiting soils coverage which was observed during the Site Walkover.
- Permanent Capping and Restoration Soils Works 2025 is two weeks ahead of schedule, with proposed completion date now expected to be 15th of August 2025.
- *Pwllfawatkin Gas Well Drilling CQA Plan Infnis June 2025* regarding the installation of four permanent gas wells on the crest of Tip 890 was approved by NRW on the 3rd of July 2025 prior to the visit.
 - FCC informed NRW that the current pin-well configuration will remain until after the

new gas wells have been commissioned, these will then be removed as necessary following a period of gas flow and quality monitoring.

- INFINIS propose for these works to be undertaken in August.
- NRW Officers observed both the completed and partially completed spinal drainage infrastructure which is associated with the surface-water drainage of Tip 890.
- No Landfill Gas (LFG) detected by the NRW Officer during the visit.
- GPS ground level surveying data was collected by CCC during the visit.
- NRW were informed that all in-situ and lab analysis facilitated by Sirius Group have passed assurance testing.
- NRW were informed that an additional 5 samples are awaiting analysis.
