4. Details of our assessment

This was a pre-planned audit carried out by Natural Resources Wales Environment Officers on 18/03/25 accompanied by DCWW Operatives.

The weather was dry and had been for several days prior to the visit.

Officers were taken through the works starting at the inlet. The permit for the site is for the discharge of treated sewage effluent. There is no storm facility at the site.

The inlet flow is screened before entering a septic tank. The flow then enters a percolating filter bed before entering a sequence of settlement tanks for further treatment.

Condition 7 states that a calibrated apparatus, approved in writing by the Authority, shall be provided and maintained in full working order, to permit the instantaneous rate of flow of effluent discharged to be measured accurately at any time. There was no flow meter on site.

Action: Install a flow meter
