Natural Resources Wales Officer Shaun Rees attended Offas Dyke Business Park on the

24 June 2025 at 12:00 to carry out an inspection of the sewage treatment plant and its outfall in relation to this permit number.

Part A

We were made aware that the permit holder is now in fact Welsh Government, and no longer Welsh Development Agency. Please ensure that the permit is updated with the correct holders details.

Please ensure this is completed by the 5 September 2025

Condition 1

During the site visit i was unable to gain access to the outfall point due to large volumes of vegetation.

The said outlet shall be designed, constructed and maintained so as to enable samples of the effluent to be obtained to the satisfaction of the authority at all times

Please ensure this is rectified and photographic evidence is provided to NRW by 5 September 2025.
