4. Details of our assessment

This compliance assessment report is being produced following an announced inspection of Glaslyn workshop. The inspection was conducted by Luke Taylor (Waste Regulation Officer) assisted by Gillian Coates (Hazardous Waste Regulation Officer) of Natural Resources Wales.

The weather at the time of the inspection was hot and dry, with no wind. The site was operational at the time and the officers were accompanied by the site operator throughout.

W4B - Reporting - Permit Condition 4.2.2 - Category 4 Breach

You have been scored for the above breach as your permit states that:

'within one month of the end of each year, the operator shall submit to Natural Resources Wales using the form made available for the purpose, the information specified on the form relating to the site and the waste accepted and removed from it during the previous year'

No waste returns have been submitted for the year 2024, which should have been received by the end of January 2025. To rectify this breach, please ensure that the outstanding waste returns for 2024 are submitted by the deadline below. This will enable Natural Resources Wales to track waste and identify whether waste is being handled correctly, in line with regulations and the waste duty of care. These waste returns must be submitted even if the site did not accept or remove any waste during these reporting periods.

ACTION - Submit outstanding waste returns to NRW. Deadline 31/08/2025

The Fire Prevention and Mitigation Plan (FPMP) for the site has been completed, with a copy located at the entrance to the site for the Fire and Rescue Service to access, if required.

Hazardous waste was being stored appropriately, and there was no evidence of any pollution arising from the activities.

Other Matters

There was a small quantity of scrap metal waste, consisting of brake discs and other other

components which are awaiting disposal, being stored on the impermeable concrete surface within the adjacent shed. This is outside of the permit boundary.

This deposit is considered to be an illegal waste deposit and is not being recorded as part of the permit compliance assessment. Please ensure that the scrap metal is disposed of at an authorised facility as soon as possible. Further communication regarding this will be sent to you as a separate matter.
