CARS form generated following site visit to Coed y Fron sewage treatment works on the 07/07/25.

Natural Resources Wales environmental officer for Meirionnydd and Dwyfor met with the performance manager, operations supervisor and the pollution tech at the site.

Site is not currently in operation. Effluent is currently being tankered away from a separate tank on site. Works expected to be completed in the near future. Inspected the work that had been carried out so far. New pipework to discharge location is also being installed.

No access to the discharge location on the day due to works.
