4. Details of our assessment

Thank you for your co-operation during the visit.

The visit took place on a hot day during a dry period.

It was seen that the primary tank was about half full and the contents was green in colour, indicating that it had been there for a while. Comments were made that the flow into the works is low and there was no flow onto the filter bed.

There was nothing on the surface to suggest that the primary tank leaks, but the colour of the tank contents and lack of flow onto the filter bed does raise the question whether the primary leaks to ground, or not.

Please inspect the primary tank for leaks when next emptied.
